Adopt Resolution Number 24-4263 Approving Fiscal Year 2024-25 Project List for SB1: The Road Repair and Accountability Act.

**DISCUSSION/BACKGROUND**

On April 28, 2017, the Governor signed Senate Bill (SB) 1. SB1 increases per gallon fuel excise taxes; increases diesel fuel sales taxes, increases vehicle registration fees, and provides for inflationary adjustments to tax rates in future years. Beginning November 2, 2017, the State Controller will deposit various portions of this new funding into the newly created Road Maintenance and Rehabilitation Account (RMRA). The RMRA program was created to address deferred maintenance on the state highway system and the local street and road system.

A percentage of the Road Maintenance and Rehabilitation Account (RMRA) funding is apportioned by formula to eligible cities and counties pursuant to Streets and Highways Code Section 2032(h) for basic road maintenance, rehabilitation, and critical safety projects on the local street and roads system.

The Town's RMRA Revenue for Fiscal Year 2024-25 SB1 program is estimated to be \$76,496. As such, Town staff has proposed a budget of \$76,000 for the upcoming FY 2024-25 budget in capital improvement project SB-6024. Funds made available by the program are required to be used for projects that include but are not limited to the following: road maintenance and rehabilitation, safety projects, railroad grade separations, complete street components, including active transportation purposes, pedestrian and bicycle safety projects, transit facilities, drainage, and storm water capture projects in conjunction with any other allowable project or traffic control devices.

Each year, staff is required to submit a project list and Resolution for the upcoming fiscal year for Town Council approval as required by the SB1 program. The Town intends to use SB1 funds to support the Town's paving program by allocating these funds to the Curb, Gutter, Sidewalk and Street Replacement Program (SB-6024). The work will include improvements to concrete work in advance of the Annual Streets Maintenance and Paving Program (MT-3025), and improvements to existing pathways. The reason behind finishing concrete work in advance of the street project is that traditionally, the paving and concrete work were combined in the same contract. However, staff has determined this can cause delays to the Measure T paving projects due to the concrete subcontractor not meeting the general contractor's paving schedule. In addition to this work that promotes efficient scheduling, these funds will also be used to repair damaged areas on pedestrian paths.

Staff recommends approving the attached fiscal year 2024-25 project list for SB1: The Road Repair and

Accountability Act.
