**A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF YOUNTVILLE
ADOPTING RESOLUTION 24-4285 FOR A PROFESSIONAL SERVICES AGREEMENT
FOR THE TOWN OF YOUNTVILLE'S ON-CALL ARBORIST TO REVIEW AND REVISE THE
TOWN OF YOUNTVILLE'S MUNICIPAL CODES ON TREES: "YMC 12.16", "YMC 17.128",
AND "YMC 17.236.010" IN AN AMOUNT NOT TO EXCEED \$20,000 FOR FISCAL YEAR
24/25**

Recitals

- A. In August 2023, the Town entered into a one-year Professional Service Agreement with Tony Wayne Wolcott, Consulting Arborist, to provide on-call arborist work.
- B. Since August 2023, Town Arborist, Tony Wayne Wolcott, has done exceptional work in supporting the Planning and Building Department with reviews and recommendations for tree removal applications as well as other on-call arborist work, as necessary.
- C. Town staff seeks to enter into a new agreement with Tony Wayne Wolcott, On-Call Arborist for the Town of Yountville, to complete review and revise the Yountville Municipal Code ("YMC") for Trees: YMC 17.128, YMC 12.16, and YMC 17.236.010 and additional tasks and work, as related and required. These tasks include not limited to presentation development and presenting, Municipal code drafting and recommendations, and meeting with staff, the public, elected bodies, and all stakeholders in the revisions.

Now therefore, the Town Council of the Town of Yountville does resolve the following:

- 1. The Town Council hereby adopts the Resolution approving a Professional Service Agreement with Tony Wayne Wolcott, On-Call Arborist for the Town of Yountville, to complete review and revise the Yountville Municipal Code ("YMC") for Trees: YMC 17.128, YMC 12.16, and YMC 17.236.010 and additional tasks and work, as related and required. These tasks include not limited to presentation development and presenting, Municipal code drafting and recommendations, and meeting with staff, the public, elected bodies, and all stakeholders in the revisions.
- 2. The Town Council authorizes the Town Manager to sign the Agreement and amendments.
- 3. The Resolution is hereby adopted and becomes effective and in full force beginning July 1, 2024.
