The Town reached out to HCD to request a meeting to discuss the second findings letter.	May 15, 2023

HCD responded to the Town and told them to prepare revisions and submit them to HCD for review.	May 24, 2023
The Town resubmitted informal revisions to HCD vis email.	July 5, 2023

The Town reached out to HCD to see if they have reviewed the revisions and if they can provide feedback.	August 9, 2023

HCD responded and said they would be reviewing the draft revisions and respond in two weeks.	August 16, 2023
HCD provided preliminary revisions to the Town.	September 19, 2023
The Town provided responses to HCD's comments.	September 26, 2023
HCD provided follow up response to the Town's responses.	September 27, 2023
The Town set up a meeting with HCD's staff, but it was canceled due to HCD staff being out sick.	October 4, 2023
The Town reached out to HCD to reschedule the meeting that was canceled.	October 9, 2023
The Town had a meeting with HCD to review the outstanding items.	October 19, 2023
The Town revised the Housing Element and provided additional revisions to HCD for review.	December 7, 2023
The Town scheduled a conference call with HCD on January 3 <sup>rd</sup> to review the latest draft edits.	January 3, 2024
The Town made further revisions to their draft HE and requested a conference call with HCD.	January 31, 2024
The Town had a meeting with HCD on the latest draft revisions. The Town agreed to revisions the draft document and provide revisions to HCD the 3 <sup>rd</sup> week of February and then HCD staff would review and have a call the last week of February.	February 7, 2024
The Town provided the latest draft HE to HCD staff for review.	February 22, 2024
The Town followed up with HCD and requested a conference call but did not receive a response.	February 26, 2024
The Town posted the updated HE on the Town's website.	February 29, 2024
The Town resubmitted the HE to HCD for another formal 60-day review.	March 8, 2024
The Town reached out to HCD to confirm receipt of the draft document and inquire about a review and revisions so the Town can adopt the Housing Element in May.	March 13, 2024
The Town had a meeting with HCD to discuss revisions.	April 17, 2024
The Town submitted revisions to HCD based on the April 17, 2024 conference call with HCD.	April 17, 2024
The Town had a conference call with HCD to confirm the revisions addressed HCD concerned and agreed to repost on the Town's website.	April 25, 2024
HCD 60-day response letter is due.	May 7, 2024
The Town will take the draft HE to their Zoning and Design Review Board for review and authorization to the Town Council.	May 14, 2024
The Town will take the draft HE to Town Council for adoption.	June 4, 2024
The Town will then submit the adopted HE back to HCD for final certification.	June 7, 2024
