Tentative Agreement Between the Town of Yountville and Yountville Employee Association (YEA) and YEA – Mid-Management and Professional Bargaining Units Negotiating Jointly

The representatives of the YEA and YEA Mid-Management and Professional units have met with the Town's representative to negotiate the terms and conditions of a successor labor agreement that expires June 30, 2021.

The Employee Groups have negotiated jointly, and have reached a tentative agreement as follows:

For YEA and YEA – Mid-Management and Professional Bargaining Units, the appropriate bargaining unit MOU's will be modified to reflect the following language changes -

YEA and YEA Mid Management Professional Bargaining Units agreed jointly to extend the terms and conditions in the existing MOU expiring June 30, 2021;

- a) This extension does not include a COLA (Cost of Living Adjustment) for this one-year period.
- b) Authorize a onetime Essential Worker Recognition stipend in the amount of \$1,500. This taxable stipend shall be provided to all full-time employees currently on active payroll who were employed as of March 14, 2020 in recognition of their contributions and efforts in responding to the COVID19 pandemic during the past year.
- c) All other terms and conditions of the MOU's remain in effect. This extension would be effective July 1, 2021 to June 30, 2022. It is recognized by the Town and bargaining groups that they will meet and confer upon expiration of this contract.
