Resolution Number 22-4121

**APPROVING PLANS AND AUTHORIZING SOLICITATION OF BIDS FOR
MT-3023; MEASURE T STREET REHABILITATION AT VARIOUS
LOCATIONS**

Recitals

- A. In November 2012, the voters of Napa County approved a ½-cent sales tax known as Measure T, implemented July 1, 2018, to be used for maintenance, reconstruction, and/or rehabilitation of streets, sidewalks, and transportation infrastructure within the public right-of-way.
- B. At the December 7, 2021 Town Council meeting, Council approved the 5 Year Measure T plan for Fiscal Years 22/23 to 26/27 which includes the rehabilitation of Yount Mill Road from Yount Street to the Town Limits, Mesa Ct. from Yountville Crossroad to end, Humboldt St. from Washington St. to Yount St., and Harvest Ct. from Heritage Way to end, Finnell Rd from Yount St. to the east Town limits, and Yountville Crossroad from Yount St. to the east Town limits. The project locations were selected to address streets with a lower pavement condition index rating.
- C. This project consists of the rehabilitation of the Yount Mill Road from Yount Street to the Town Limits, Mesa Ct. from Yountville Crossroad to end, Humboldt St. from Washington St. to Yount St., and Harvest Ct. from Heritage Way to end, Rehabilitation to consist of grinding the existing asphalt and or/ overlaying the street surface with new hot-mix asphalt. Also included in this project are repairs to smaller sections of roadway on Finnell Rd from Yount St. to the east Town limits, and Yountville Crossroad from Yount St. to the east Town limits in preparation for the following fiscal year's microsurfacing project.
- D. The design for this project was prepared by Pavement Engineering Inc. (PEI) with the construction plans completed in May 2022.
- E. The engineer's estimate of probable construction cost is \$293,348. The MT-3021 available budget for this project is \$550,000.
- F. Staff requests the Town Council approve and adopt the plans and working details and authorize staff to publicly bid the MT-3023, Measure T Street Rehabilitation at Various Locations.
- G. This project is categorically exempt under Section 15302(c) Categorical Exempt per California Environmental Quality Act (CEQA) Guideline; Class 2, Replacement or Reconstruction.

Now therefore, the Town Council of the Town of Yountville does resolve as follows:

- 1. Approve and adopt the design and plans for the MT-3023, Measure T Street Rehabilitation at Various Locations.
- 2. Authorize the solicitation of bids for the construction of the MT-3023, Measure T Street Rehabilitation at Various Locations.

3. The Resolution is hereby adopted and becomes effective and in full force immediately upon adoption.
