Resolution Number 22-4136

AWARDING THE BID FOR THE MT-3023 MEASURE T STREET REHABILITATION AT VARIOUS LOCATIONS PROJECT TO J.V. LUCAS PAVING OF MARTINEZ, CA FOR \$318,967.30 AND AUTHORIZING THE TOWN MANAGER TO EXECUTE A CONSTRUCTION CONTRACT, CHANGE ORDERS AND AMENDMENTS UP TO THE MT-3023 BUDGETED AMOUNT.

Recitals

- A. In November 2012, the voters of Napa County approved a ½-cent sales tax known as Measure T which was implemented July 1, 2018. Measure T funding is to be used for maintenance, reconstruction, and/or rehabilitation of streets, sidewalks, and transportation infrastructure within the public right-of-way.
- B. At the June 21, 2022, Town Council meeting, Council approved Resolution 22-4133 adopting the 2022-2023 Capital Improvement Program with MT-3023, the Annual Street Maintenance and Paving Program. This year's Measure T Project MT-3023 consists of the rehabilitation of the Yount Mill Road from Yount Street to the Town Limits, Mesa Ct. from Yountville Crossroad to end, Humboldt St. from Washington St. to Yount St., and Harvest Ct. from Heritage Way to end, Rehabilitation to consist of grinding the existing asphalt and overlaying the street surface with new hot-mix asphalt. Also included in this project are repairs to smaller sections of roadway on Finnell Rd from Yount St. to the east Town limits, and Yountville Crossroad from Yount St. to the east Town limits in preparation for the following fiscal year's microsurfacing project.
- C. At the May 17, 2022, Town Council meeting, Council approved the plans and specifications for MT-3023, the project described above. The formal bid package was advertised in the construction trade journals and the Town's virtual plan room on May 20, 2022 with a 30-day solicitation period. The Town received one bid that was publicly opened and read aloud on June 22, 2022 at 2:00 pm.
- D. The apparent low bidder is J.V. Lucas Paving of Martinez, CA. The bid package received from J.V. Lucas Paving contains no errors or inconsistencies and as such J.V. Lucas Paving is the apparent lowest responsive and responsible bidder at the price of \$318,967.30.
- E. This project is categorically exempt under Section 15302(c) Categorical Exempt per California Environmental Quality Act (CEQA) Guideline; Class 2, Replacement or Reconstruction.

Now therefore, the Town Council of the Town of Yountville does resolve as follows:

- 1. Award the bid for the Measure T Street Rehabilitation at Various Locations MT 3023, to J.V. Lucas Paving of Martinez for \$318,927.30.
- 2. Authorize the Town Manager to execute a construction contract, change orders and amendments up to the MT 3023 budget amount.
- 3. The Resolution is hereby adopted and becomes effective and in full force immediately upon adoption.
