Regarding your proposed project when compared to the proposed ADA project, we are comparing apples to oranges.

- 1. Apples: Your proposed project is vertical construction above the ground located within the conservation easement, the purpose of which is the protection of riparian habitat and hydraulic capacity of Hopper Creek as it is located along the creek bank.
- 2. Oranges: The proposed ADA project is horizontal construction on the ground located outside of the conservation easement will not affect the riparian habitat and will not affect the hydraulic capacity of Hopper Creek as it is located along the street side of the park, not the creek bank side of the park.

Also, I would like to bring your attention to the third proposal for the project that would eliminate the parallel public parking along the Three Weirs Park property frontage which in turn eliminates the need for the ADA parking stall. In that configuration the project will consist of reconstruction the path from the street to the bridge to meet ADA Design criteria as required by federal law. Good question based on your experience with your ADU and the Town's development review process. The Town has two engineers on staff who manage the Town's project's such as this one and we evaluate all aspects of a proposed

project. We also hired a consultant engineer to prepare the design in compliance with all of the applicable regulations associated with the proposed project. Additionally, we follow the same process and standards as we require of a private project for the Town's projects.

For the Three Weirs site, the footprint for the proposed ADA project lies entirely outside of the conservation easement and also outside the Department of Fish and Wildlife jurisdiction. Neither the path nor the parking stall (if it remains in the design) are subject to either condition as neither fall within the riparian habitat nor effect the hydraulic capacity of the creek.

Site Meeting: Staff will be scheduling a site walk meeting on a date and time certain the week of November 14th. When that is set, we will reach out to give people the opportunity to attend and ask questions. Responses to your numbered questions are as follows:

- Town staff will collect input from all the residents in the public meetings then present the original design, the revised designs from the first meeting, the proposed revisions from the second meeting and staff's recommendations to the Parks & Recreation Commission asking for their preference. The design will then be selected in a fair and equitable manner based on all the above.
- These two project locations within the Washington Park neighborhood were identified in the Town's ADA Transition Plan and as such have been included in the Town's Capital Improvement Program (CIP). Town Public Works staff were aware of the need to fund and construct this project as part of the CIP, therefore they applied for and received grant monies specific to this type of project.
- 3. The Town has an adopted ADA Transition Plan that is required by federal law that serves as the Town's ADA compliance strategy. That plan was developed through a facilities analysis, feedback and prioritization through public meetings and ultimately adopted as policy by Town Council.
- 4. Three Weirs Park is not only a park, but the starting and stopping point for the residents who live in Washington Park to access the Hopper Creek Trail and the rest of Town in a safe pedestrian environment. Regarding other locations along the path, the Three Weirs site is consistent with those at Wood Duck Cove along Heather Street and Oak Circle Park, and you are correct, there

are other opportune locations along Hopper Creek path such as Finnell that additional access could be provided. The difference being, those other locations would not provide access from the Washington Park corner of Town to the path.

Please also consider that the Town may not make a determination about a public facility that has the effect of excluding or discriminating against persons with disabilities.

By NOT providing equal access to the public location of Three Weirs Park AND its bridge that connects Washington Park to the Hopper Creek Path we are making a decision that denies people access and excludes or discriminates against persons with disabilities.

 - 2. Why 3 Weir, and not ADA parking in more visible and more heavily trafficked streets that ALSO connect the path, such as on Finnell, any where west of the bridge and Yount Street? and/or at Yount at near the point at which the path meets the sidewalk? (yes, I raised this in the 2nd mtg and am still not clear on "why not" in these other locations that do connect paths and parks. There are no ADA parking spots along Finnell on either the south or north side.

I can think of more topics, but for now, I'll hold off. I am curious to learn: how does what I am proposing land on you? Does it raise concerns I may not be thinking of?

So why is it being pushed for Three Weir? The Town implemented an ADA evaluation plan to provide access to public facilities. This plan specifically included Three Weirs Park as a public facility that would be addressed. Three Weirs Park, although small, is a nice park with a direct connection to the pedestrian bridge that leads to the trail. So, if that is the case, the Town added it to it's plan, it can be agreed upon that this the town making the decision to do this to Three Weirs. It is not REQUIRED, as has been stated. Then I believe that much more recognition has to be given to the voice of the residents in the area of Three Weirs. Not one person is arguing that parks should not be available to disabled people, they are arguing that it is a mistake to make such an invasive and huge change to a green space, that is NOT a park, especially when it is not necessary or required. I think it is time to revise that "plan" and take Three Weir off the list.

Carlton stated that the existing path is not at the correct grade to be legally accessible.

That is true, but only a very small section of the grade of the existing path is at 7% instead of 5%. When you and I met at the park that day you mentioned that the existing walking path would be being upgraded in this process, so why not just fix the tiny area that is currently not at 5% and use that path? It is completely doable without adding a huge path that takes up 2/3 of the "park" space. For Three Weirs Park we modified the original plan to include the walkway through the park. The feedback from the second meeting showed a preference to the parallel parking design from the first meeting that is closer to the existing entrance. The grade on the existing path up to the bridge will be addressed with this project. The accessible parking spot and loading zone also must meet grade requirements. In the parallel parking stall scenario, we cannot meet the grades for the parking stall and tie into the existing pathway up to the bridge without the ramp. Yes, it did sound like people prefer the parallel parking option for this location, but it does not have to included a huge long wall with railings if just the existing ramp is correctly graded.

It has been repeated that grant money has been received for this project.

Isn't the grant money only for the engineering design of the project and not for the construction? The grant design is for the both the design and the construction. We do not receive additional money for the construction. I am not clear on this. The grant is for both, design and construction? How much is the grant?

It has been stated that this was designated as a "park" in 1996.

Since no features were ever added can it not be re-designated in 2022 as green space? If not, why not? The intent of this project is to provide accessibility to public facilities and not to remove park facilities from the Town list. I can make a note of your request to have this re-designated as a green space for a future item. Thank you.

It was stated that the one tree being removed in plan 1 design was dying anyway.

I do not believe that to be true, several of those trees are the kind that hold their dried leaves until spring, so that comment might be mistaken. The project will have trees evaluated before removal. The Town does not like removing

trees if not necessary. We will evaluate the condition of the tree and the impact the construction will have to the root system. One of the goals of the first design option (the parallel parking stall) at Three Weirs was to avoid major impacts to the trees in the park. Good to hear.

And finally, regarding Forrester Park, in Plan 2, I sent in a question asking if the ADA parking space could be moved to the south so that we could keep on parking spot in front of Forrester Park and add the ADA space, instead of locating the ADA parking spot in the middle thereby losing a general parking space. The parking stall at Forrester Park will have to tie into the walkway that is existing . Fortunately, this area is relatively flat and making the pedestrian connection will not require any walls or ramps. We cannot place a parallel stall further south of the southern park walkway because there appears to be a driveway and a mailbox that we cannot obstruct. We could go further north but the pull in stall in option two appears to be the least impactful. I will have the designer look at potentially moving the parking stall to the north where there is room. I guess I did not make my comments clear in the previous email. My question is can the straight in parking spot at Forrester Park just be slid to the south to the light post, still keeping it in the front of the park. That way another car can park on the parking shoulder. I would be glad to explain in person if you are planning on making a site visit.

Site Meeting: Staff will be scheduling a site walk meeting on a date and time certain the week of November 14th. When that is set, we will reach out to give people the opportunity to attend and ask questions. Responses to your numbered questions are as follows:

- Town staff will collect input from all the residents in the public meetings then present the original design, the revised designs from the first meeting, the proposed revisions from the second meeting and staff's recommendations to the Parks & Recreation Commission asking for their preference. The design will then be selected in a fair and equitable manner based on all the above.
- These two project locations within the Washington Park neighborhood were identified in the Town's ADA Transition Plan and as such have been included in the Town's Capital Improvement Program (CIP). Town Public Works staff were aware of the need to fund and construct this project as part of the CIP, therefore they applied for and received grant monies specific to this type of project.

Regarding other locations along the path, the Three Weirs site is consistent with those at Wood Duck Cove along Heather Street and Oak Circle Park, and you are correct, there are other opportune locations along Hopper Creek path such as Finnell that additional access could be provided. The difference being, those other locations would not provide access from the Washington Park corner of Town to the path.

Please also consider that the Town may not make a determination about a public facility that has the effect of excluding or discriminating against persons with disabilities.

Thanks for sharing this email exchange. I'm jumping in here; the headline of this message is: When can we have another meeting that includes a walk around the proposed areas?

Note that yes, I am assuming another meeting is doable. I earnestly ask for this because I think this would allow for speedier understanding and it can be more productive and efficient than lots and lots of emails. I'm not saying the emails are **in**effective! Just seems there are so many questions and ideas that it's getting to the point that a discussion, rather than lots and lots of emails, would be (more) productive. (And tracking the colors can be a challenge for those whose tech tools don't allow color (e.g., some iPads). Concerns about this idea? If not, when can we schedule one?

In addition to Kim's questions, the questions I propose the agenda includes:

- 1. First and foremost: Who makes the final design decisions? Is it a "vote" by interested residents? is it Rosalba? Steve? John? I am asking as it matters to know this upfront.
 - Here's what leads me to say this: When ideas are solicited, and yet it is not clear or explicit who is "the decider" or how the final design and location decisions will be made, it leads to frustration and in turn, can demotivate people from participating in this kind of community discussion. I can see people thinking, "why bother" if the decision had already been made, for example. I am NOT saying decisions about design has been made, but with so many ideas and questions, at this point, it begs the question: who decides the final location and design?

- 3. How does this fit into an overall ADA compliance strategy for the whole town, assuming there is one?
- 4. What led to identifying 3 Weirs as one of the ADA parking space locations?
 - 1. What data is being used to say ADA parking is needed at 3 Weir park, at this point in the history of Wash Park? Said more succinctly, why now? Steve, can you explain in a mtg this it's just puzzling to me. Something is missing for me about this or that I am not aware of or understanding.
 - 2. Why 3 Weir, and not ADA parking in more visible and more heavily trafficked streets that ALSO connect the path, such as on Finnell, any where west of the bridge and Yount Street? and/or at Yount at near the point at which the path meets the sidewalk? (yes, I raised this in the 2nd mtg and am still not clear on "why not" in these other locations that do connect paths and parks. There are no ADA parking spots along Finnell on either the south or north side.

I can think of more topics, but for now, I'll hold off. I am curious to learn: how does what I am proposing land on you? Does it raise concerns I may not be thinking of?

This plan specifically included Three Weirs Park as a public facility that would be addressed. Three Weirs Park, although small, is a nice park with a direct connection to the pedestrian bridge that leads to the trail. So, if that is the case, the Town added it to it's plan, it can be agreed upon that this the town making the decision to do this to Three Weirs. It is not REQUIRED, as has been stated. Then I believe that much more recognition has to be given to the voice of the residents in the area of Three Weirs. Not one person is arguing that parks should not be available to disabled people, they are arguing that it is a mistake to make such an invasive and huge change to a green space, that is NOT a park, especially when it is not necessary or required. I think it is time to revise that "plan" and take Three Weir off the list.

Carlton stated that the existing path is not at the correct grade to be legally accessible.

That is true, but only a very small section of the grade of the existing path is at 7% instead of 5%. When you and I met at the park that day you mentioned that the existing walking path would be being upgraded in this process, so why not just fix the tiny area that is currently not at 5% and use that path? It is completely doable without adding a huge path that takes up 2/3 of the "park" space. For Three Weirs Park we modified the original plan to include the walkway through the park. The feedback from the second meeting showed a preference to the parallel parking design from the first meeting that is closer to the existing entrance. The grade on the existing path up to the bridge will be addressed with this project. The accessible parking spot and loading zone also must meet grade requirements. In the parallel parking stall scenario, we cannot meet the grades for the parking stall and tie into the existing pathway up to the bridge without the ramp. Yes, it did sound like people prefer the parallel parking option for this location, but it does not have to included a huge long wall with railings if just the existing ramp is correctly graded.

It has been repeated that grant money has been received for this project.

Isn't the grant money only for the engineering design of the project and not for the construction? The grant design is for the both the design and the construction. We do not receive additional money for the construction. I am not clear on this. The grant is for both, design and construction? How much is the grant?

It has been stated that this was designated as a "park" in 1996.

Since no features were ever added can it not be re-designated in 2022 as green space? If not, why not? The intent of this project is to provide accessibility to public facilities and not to remove park facilities from the Town list. I can make a note of your request to have this re-designated as a green space for a future item. Thank you.

And finally, regarding Forrester Park, in Plan 2, I sent in a question asking if the ADA parking space could be moved to the south so that we could keep on parking spot in front of Forrester Park and add the ADA space, instead of locating the ADA parking spot in the middle thereby losing a general parking space. The parking stall at Forrester Park will have to tie into the walkway that is existing. Fortunately, this area is relatively flat and making the pedestrian connection will not require any walls or ramps. We cannot place a parallel stall further south of the southern park walkway because there appears to be a driveway and a mailbox that we cannot obstruct. We could go further north but the pull in stall in option two appears to be the least impactful. I will have the designer look at potentially moving the parking stall to the north where there is room. I guess I did not make my comments clear in the previous email. My question is can the straight in parking spot at Forrester Park just be slid to the south to the light post, still keeping it in the front of the park.



Good afternoon. I am glad you were able to view the zoom meeting via the website. I place the information on the project webpage and hope that it is viewable by all. It is good to hear this confirmation. I have provided responses to your questions/comments below in red. I am also working with the engineer to determine what modifications we can do to the design to accommodate the feedback we received but still meet requirements. I will be taking this project to the November 17th PRAC meeting as well. I will host a field meeting at the two parks either before the PRAC meeting or shortly thereafter.

It was stated that ADA Title II requires the town to place ADA parking in these two parks.

Directly from Title II of the Americans with Disabilities Act; "Public entities, however, are not necessarily required to make each of their existing facilities accessible." Previous research that I have done on this explains that when a location holds no specific element or feature that is not found in another location in town it is not necessary that location accessible. So why is it being pushed for Three Weir? The Town implemented an ADA evaluation plan to provide access to public facilities. This plan specifically included Three Weirs Park as a public facility that would be addressed. Three Weirs Park, although small, is a nice park with a direct connection to the pedestrian bridge that leads to the trail. So, if that is the case, the Town added it to it's plan, it can be agreed upon that this the town making the decision to do this to Three Weirs. It is not REQUIRED, as has been stated. Then I believe that much more recognition has to be given to the voice of the residents in the area of Three Weirs. Not one person is arguing that parks should not be available to disabled people, they are arguing that it is a mistake to make such an invasive and huge change to a green space, that is NOT a park, especially when it is not necessary or required. I think it is time to revise that "plan" and take Three Weir off the list.

Carlton stated that the existing path is not at the correct grade to be legally accessible.

That is true, but only a very small section of the grade of the existing path is at 7% instead of 5%. When you and I met at the park that day you mentioned that the existing walking path would be being upgraded in this process, so why not just fix the tiny area that is currently not at 5% and use that path? It is completely doable without adding a huge path that takes up 2/3 of the "park" space. For Three Weirs Park we modified the original plan to include the walkway through the park. The feedback from the second meeting showed a preference to the parallel parking design from the first meeting that is closer to the existing entrance. The grade on the existing path up to the bridge will be addressed with this project. The accessible parking spot and loading zone also must meet grade requirements. In the parallel parking stall scenario, we cannot meet the grades for the parking stall and tie into the existing pathway up to the bridge without the ramp. Yes, it did sound like people prefer the parallel parking option for this location, but it does not have to included a huge long wall with railings if just the existing ramp is correctly graded.

It has been repeated that grant money has been received for this project.

Isn't the grant money only for the engineering design of the project and not for the construction? The grant design is for the both the design and the construction. We do not receive additional money for the construction. I am not clear on this. The grant is for both, design and construction? How much is the grant?

It has been stated that this was designated as a "park" in 1996.

Since no features were ever added can it not be re-designated in 2022 as green space? If not, why not? The intent of this project is to provide accessibility to public facilities and not to remove park facilities from the Town list. I can make a note of your request to have this re-designated as a green space for a future item. Thank you.

It was stated that the one tree being removed in plan 1 design was dying anyway.

I do not believe that to be true, several of those trees are the kind that hold their dried leaves until spring, so that comment might be mistaken. The project will have trees evaluated before removal. The Town does not like removing trees if not necessary. We will evaluate the condition of the tree and the impact the construction will have to the root system. One of the goals of the first design option (the parallel parking stall) at Three Weirs was to avoid major impacts to the trees in the park. Good to hear.

And finally, regarding Forrester Park, in Plan 2, I sent in a question asking if the ADA parking space could be moved to the south so that we could keep on parking spot in front of Forrester Park and add the ADA space, instead of locating the ADA parking spot in the middle thereby losing a general parking space. The parking stall at Forrester Park will have to tie into the walkway that is existing. Fortunately, this area is relatively flat and making the pedestrian connection will not require any walls or ramps. We cannot place a parallel stall further south of the southern park walkway because there appears to be a driveway and a mailbox that we cannot obstruct. We could go further north but the pull in stall in option two appears to be the least impactful. I will have the designer look at potentially moving the parking stall to the north where there is room. I guess I did not make my comments clear in the previous email. My question is can the straight in parking spot at Forrester Park just be slid to the south to the light post, still keeping it in the front of the park. That way another car can park on the parking shoulder. I would be glad to explain in person if you are planning on making a site visit.

Yes, this one is a real park, so I can understand adding an ADA parking space, though putting one is an official "non-compliant" neighborhood still seems odd.

My last suggestion for the recent design update is to move the ADA parking space to the right, as close as possible to the existing light post, so that the access is as short as possible and right next to the ADA ramp and pathway to the park.


That way there will still be a general public parking space in front of the park on the left side of the ADA spot without blocking that north pathway into the park. As shown now a person could park on the parking shoulder on either side of the ADA spot and block access to the pathway. By moving the ADA spot south it would eliminate that possibility on the right side completely so that no one blocks the ADA access, and open up a spot for a well used parking space.

Good morning. It was nice meeting you in person as well. I will bring up your question to our design engineer. In our project initiation meetings with our designer, we indicated that goals for the project were to provide the accessible stall, minimize the impact to the park, and have the design fit with the neighborhood. The revised design alternative moved the stall away from the existing ramp. In this new design the asphalt shoulder that is currently existing is not a sidewalk path but a parking shoulder. To make this stall ADA compliant, not construct the walkway through the park and provide a path along the street, the asphalt shoulder would have to be a designated walkway. We would have to restrict parking on that section. I can mention this option at the upcoming community meeting. The existing ramp to the pedestrian bridge will still have to be reconstructed to meet ADA requirements as well. Thank you for your input!

We were excited to be able to modify the original design to incorporate many of the recommendations we received in the first community meeting. The suggestions we received were very beneficial to the ultimate design. Regarding your comments on the revised renderings, I will attempt to respond to each item below.

1. the depth of the ADA parking space should start at the street edge of the parking shoulder, not the edge of the grass so as to make the invasion of the park/lawn area smaller.

<u>Town response:</u> Great suggestion. The final design will take this into consideration. Although these renderings are close to the final design, they are only renderings of an unfinished design. After we present this to the community, in the October 20th meeting, the Town will meet with the designer and adjust the final layout as needed. I have made a note of this suggestions and will review it with the design engineer. Super thank you.

2. the graphic of the meandering walkway to the bridge is nice but it makes the park look flat. In reality it crosses a large grass knoll that is much beyond the 5% grade allowed so it would require a large amount of grading and retaining walls and possibly damage the roots of the trees at the south of the walkway.

<u>Town response</u>: The ADA compliant grade and slope of the proposed walkway is one of the main criteria in this design. In the previous design, a retaining wall was required due to the steep grade of the walkway. By increasing the length of the ramps and the walkway through the park we are able to eliminate the requirement for a rail and retaining wall. This is a rendering of a draft design, and the design engineer will update the Town if any final calculations change this. Unfortunately, with any construction near existing trees, the tree roots and tree itself can be impacted. The Town strives to minimize the impact on healthy mature trees. It is better to assess the location of the roots and how best to avoid any major damage, during construction when the area is opened and can be viewed. The Town will try its best to protect healthy trees. Laurie's first suggestion was to zig-zag a ADA ramp, with the required landings, next to the existing path to the bridge. It could leave the existing path in place, not disrupt the lawn of the park, yet meet all the ADA slope and access requirements. I will contact her and ask her to better explain her thoughts in case she is not available for eh October 20th meeting.

3. While we were standing at the park discussing it we met a neighbor who's father lives at 25 Forrester and in fact is wheelchair bound. Laurie is also a landscape contractor. She said that she would reach out to you but in case she does not her email is <u>lauriecrutch@gmail.com</u>. Town response: The Town always welcomes additional input from the community . For this specific project, the grant funds do not cover any landscaping work that is not directly related to the construction of an ADA parking stall and path. But the Town is always interested in hearing suggestions on how to better improve our parks and pathways for future projects and improvements. Lauries input was strictly related to the design and construction of the ADA path, not the plantings.

Thank you both for the meeting last night. The information was clear and you were both generous with your time and all of our questions.

When we were out for a walk this morning we went over the bridge to Hopper Creek Pathway.

I really think that there is a simpler solution to that ADA pathway than the intrusive wall and ramp structure that was seen in the rendering.

The existing path from the bridge to the curb cut/ADA ramp averages about 4% grade with a very small part, like 10", that is at 7% near the bridge. My understanding is that a "maximum running slope allowed is 5%". Wouldn't it be possible to regrade just that area, install a nicer concrete gently sloping pathway that would meet the code verses a complex and expensive structure?

It states in the flyer that it is the Town's legal obligation to build these ADA parking spaces. Can that please be explained further, and pass along with the actual part of the ADA code that makes this a requirement?

Forrester Park has no special features that are not offered anywhere else in town, and Three Weir is not even a park but a patch of lawn and a bench. My understanding has been that not everything in every town needs to be ADA accessible if the features are available in other parts of the town, which they are, and the other parks offer much more in the way of features and play structures.

What "connectivity" is being referred to? The Hopper Creek Path does not go any farther north than Hooper Creek, there is no part of it on the north side of Washington Park to connect with.

Forrester and Three Weir are just neighborhood green spaces, much like the Tot Lot in Toyon Terrace. Lightly used by people that live one or two blocks away.

As word spreads of an On-Site Meeting for the Three Weirs/Forrester Park ADA Improvement Project, folks have questions about the meeting date & time and the process, both in the past and going forward. We are sorry for any confusion, our outreach is intended to keep interested parties informed, aware of meetings and progress of the project as it moves forward. The following will hopefully provide clarification about where we have been and where we are going:

Prior Meetings

As you are aware Town Staff conducted two public meetings to present information and receive public input about the proposed designs for the two project sites:

- 1. The first meeting presented the Three Weirs/Forrester Park ADA Capital Improvement Project with the Town's prepared designs for each site. Those designs were developed over several iterations with a design professional to meet the ADA laws and address site specific needs.
 - a. The meeting was well attended and productive in that the Town and its design professional received valuable input from the Washington Park residents regarding the designs and with requests for alternative design layouts be prepared and brought back to the group.
 - b. While the first meeting was well attended it was mostly folks who live in proximity to the Forrester Park site with less from proximity to Three Weirs Park.

After the first meeting, Town staff and our design professional prepared alternative designs based on feedback received from the first meeting then hosted a second meeting.

- 2. The second meeting presented the revised project designs for each site. Those designs included the feedback received from first meeting including turning the parking 90-degrees rather than parallel and meandering the path through Three Weirs.
 - a. The second meeting was also well attended and productive in that the Town again received valuable input from the group.
 - b. This time the second meeting was attended by mostly folks who live in proximity to Three Weirs Park with less from proximity to Forrester Park.

On-Site Meeting and the Parks & Recreation Advisory Commission

Town staff has heard from several residents that an On-Site Meeting would be beneficial to help further explain each of the preferred designs at each location. In addition to the residents, Town staff is obligated to present this project to the Parks & Recreation Advisory Commission as both sites are in Town Public Parks and connect to the Town path system. As such, Town staff has scheduled an On-Site Meeting to accommodate both parties, the residents and the Parks and Recreation Commission (PRAC).

<u>On-Site Meeting</u>

- 1. Staff scheduled the site meeting for the residents during day to allow daylight viewing and selected the date in advance of the next PRAC meeting.
- 2. The Site Meeting is November 16th at 1:00pm. the next regularly scheduled meeting of the PRAC is November 17th at 6:00pm.
- 3. In order for the commissioners to see the site together as a group in the daylight, we are obligated to schedule a published Special Meeting of the PRAC, allowing them to meet on site within the rules of the Brown Act.
- 4. The goal of the meeting is threefold, 1) to explain the proposed design physically on the ground at each site, 2) introduce the project designs to the PRAC, and 3) to receive and answer questions from all parties in attendance.
- 5. Please understand that no one meeting date will satisfy everyone's schedules, but the Town is working very hard to meet the request of the residents as well as incorporate the Parks & Recreation Commission.

Parks & Recreation Commission Meeting

- 1. In addition to the two prior meetings and the On-Site Meeting, this project will continue to be discussed at public meetings where all are welcome.
- 2. The regularly scheduled Parks & Recreation Commission Meeting is November 17th at 6:00pm in person at the Town Hall Council Chambers.
- 3. At this meeting Town Staff will be presenting a summary of the proposed designs and the alternatives that have been preferred by each group of folks that live in proximity to each site along with Town staff's recommendations for each.
- 4. The commission will then consider all of the available information and determine their preferred alternatives for each site as a recommendation to Town Council.

Town Council Meeting

After the PRAC makes their recommendation to Town Council at the November 17th PRAC meeting, Town staff will take the designs of this project forward to Town Council for their recommendation.

- 1. This is most likely going to be scheduled for a Town Council meeting in January.
- 2. After receiving Town Council input Town staff with authorize our design consultant to prepare the final, detailed design plans.
- 3. After the design is complete, Town staff will publicly bid the project for construction.
- 4. Bidding and construction will likely occur in spring/summer 2023.

Mr. Hays,

Good morning. Thank you for your interest in this Town project. Consistent with the prior public meetings and the PRAC meeting, the responses to your questions are in blue text as follows:

- 1. The rationale for ADA parking at Three Weirs Park.
 - The Town is obligated to comply with the American with Disabilities Act (ADA), a comprehensive civil rights law to assure equality of opportunity, full participation, and independent living, for people with disabilities.
 - The Town adopted an ADA transition plan in 2015 to comply with the American with Disabilities Act (ADA). As part of this ADA Transition Plan, the Town is providing accessible improvements at public facilities, public parks, and public parking throughout town.
 - Three Weirs and Forrester Park were specifically identified as lacking adequate accessible parking and access.
 - Three Weirs Park currently has public parking at public facility with no accessible parking stall and a ramp to a public pedestrian trail that is not compliant with ADA standards.
- 2. Whether alternatives exist that might better meet both legal requirements and the interests and needs of the community.
 - To date, there has not been an option that meet the legal ADA requirements and satisfy the aesthetic concerns from the handful of residents that have come forward to provide feedback. The options are as follows:
 - Install an ADA parking stall and reconstruct the ramp to the pedestrian trail to meet ADA standards.
 - Remove public street parking from this public facility and reconstruct the ramp to the pedestrian trail to meet ADA standards. This will require additional review to what will be required for ADA if there are no accessible paths within the neighborhood.
 - Do nothing. The Town has the design, the funds, and the ability to provide accessibility improvements at a public facility. If the Town chooses not to provide these improvements a greater liability issue is created. This could require the ADA transition plan to be revisited and revised and potential adjustments to entrance the Hopper Creek Pedestrian Trail.
- 3. The process the town uses to invite and evaluate design suggestions from the public.
 - Typically, when projects are smaller and do not encroach in any private property the community meetings are geared towards informational updates and not in-depth design collaborations.
 - However, given the sensitive nature of this project in this location, the Town has hosted various community meetings to collaborate with the groups of community members who have been willing to participate.
 - We have incorporated the results of those collaborative meetings and created multiple design options based off that feedback.

I'm hoping you would be willing to help me by responding to the following questions:

- 1. If ADA parking at Three Weirs Park is required by law, is it because parking already exists there? Or is it because it's a public park (regardless of whether contiguous parking exists)? In other words, if a public park exists, but no parking is available at that park, is there a requirement to install ADA parking?
 - The Town is required to provide an accessible parking stall where public parking is provided.
 - The designation of this area, regardless of it being a "park", "open space" or "public facility", is not the governing factor in the requirement for the ADA parking stall.
 - However, Three Weirs Park and this neighborhood are in a unique situation where accessible paths in the neighborhood are intentionally omitted. The omission of sidewalks was included in the ADA Transition plan based on community feedback.
 - That said, the Hopper Creek Pedestrian Trial has a direct connection to this neighborhood via an intentional pedestrian bridge and ramp that leads into the neighborhood.
 - The ramp from the neighborhood to the trail is not compliant nor is the curb cut into the street.
 - Regardless of the parking situation, the access to the pathway to the bridge needs to be ADA compliant.
- 2. If the raised shoulder that currently exists along the front of Three Weirs Park were to be reconfigured in its entirety into a conventional sidewalk with curb (eliminating parking in front of the park) would that obviate the legal requirement to install ADA parking at the park?
 - The removal of parking could remove the requirement for the ADA accessible parking stall.
 - The connection to the pedestrian trail to the neighborhood would still need to be addressed to meet ADA standards.
- 3. In lieu of the current design, which lays the wheelchair-accessible path to the Hopper Creek Path right through the park, could the existing raised shoulder be replaced by a conventional sidewalk that serves as a wheelchair-accessible path to the Hopper Creek Path?
 - The Town had multiple designs created based on community feedback and adjustments. One design has a path that cuts through the park and the other design has a path keeps to the corner of the park closest to the existing path and utilizes the area of the existing path.
 - Converting the existing raised shoulder to sidewalk is the same as removing public parking from this area. This is an option that will require review from the Town attorney as a sidewalk in front of this park would not lead to any accessible paths in the neighborhood from the trail.
- 4. Is the primary motivation for ADA parking at Three Weirs Park access to:
 - a. Hopper Creek Path? If so, why wouldn't that be more effectively and less obtrusively accomplished by ADA parking at one or both ends of the path, i.e., at Finnell Rd and/or Yount St?
 - The motivation to provide ADA parking at this location is as stated above. Three Weirs Park currently has public parking at public facility with no accessible parking stall and a ramp to a public pedestrian trail that is not compliant with ADA standards.
 - ADA Parking at other location as proposed at Finnell and Yount St fail to provide ADA access to and from the Washington Park neighborhood and contiguous Stags View neighborhood.

b. Three Weirs Park itself? If so, how would you address concerns that, given the small size of the park, the proposed ADA parking design is certain to have an inordinate impact on the aesthetic, ambience, and functionality of the park and neighborhood?

- The design consultant was given instructions to provide the least impactful design that would provide ADA compliance.
- The preferred design presented to the community that keeps the parking stall and path the far west of the park is the least impactful.
- We are utilizing as much of the existing paved shoulder and existing paved trail area as possible to minimize how much green area is removed.
- The <u>NEW</u> hard surfaces (concrete or asphalt) are approximately 500 square feet. The total park green area before this project is approximately 6,500 SF. The total parking stall would only impact approximately 8% of the park.
- There are no design options that would have no impact to this location. The land will still be accessible to the residents and their pets, the bench and trash cans will remain, and access to the pedestrian trail will remain.

5. Is there a process in place to actively solicit and evaluate design suggestions from community members? (In addition to the existing process to solicit community input on professionally prepared designs.)

- The process of hosting multiple public meetings, collaborating on the design of the project and revising the design based on that collaboration already exists and is taking place as evidenced by the attendance at the multiple public meetings.
- The size and scope of this project does not open itself to greater additional methods of soliciting design suggestions from the community.
 - For example, this project does not encroach on a private property, it does not remove a park from the neighborhood, and it does not add a change in traffic patterns that could cause harm or confusion to drivers.
 - Larger projects with a larger impact on the Town residents or drivers, could potentially include more options. The Town submitted all design suggestions received from the community to the design engineer. They reviewed the suggestions and used the elements that would still allow for ADA compliance in their revised designs.
- If the Town moves forward with this project, we will have to construct a design that was created by the licensed engineer of record. This is mandatory to verify that the design alternative is ADA compliant.

Additionally, the Town's goal is to follow the ADA Transition Plan and provide ADA compliant features as required by law. By doing nothing at this site, the Town is increasing its risk to lawsuits and fines because doing nothing has the effect of excluding or discriminating against persons with disabilities.

This accessible parking stall is the least impactful of these options. 2010 ADA standards require "[a]t least one accessible route shall be provided within the site from accessible parking spaces and accessible passenger loading zones; public streets and sidewalks; and public transportation stops to the accessible building or **facility** entrance they serve." If we choose to not provide an accessible parking stall and no accessible connection, not only could the public parking be removed but the access to the pedestrian bridge and trail may face removal as well. The Town cannot remove a project to provide ADA facilities based on public comments, courts have held this reason is insufficient to avoid ADA compliance.

The public's opportunity to participate still exists as the process moves forward to Town Council. The Town will present the updated designs and the various options explained above to the public and the Town Council. I will also include a legal insight, with the help of our Town Attorney, on various liability and legal repercussions we could face on these various project alternatives.

Here is a copy of my email regarding the proposed handicap parking at Three Weirs Parks. I was in attendance at the field meeting this afternoon and it was suggested I forward my original email regarding this matter to Public Comments.

Dear Ms. Ramirez:

Thank you for taking the time to speak with me this afternoon, regarding the new design for the ADA compliant parking place at Forrester/Three Rivers Park. There are many neighbors that do not live in their homes full-time and have not received your notices, don't know how to participate in a zoom call, or for that matter, know what's going on. By your own admission, flyers were placed on doors, etc., which would explain why so many residents did not receive your notices.

The signage at the far end of the park near the bridge just went up depicting what either the proposed plan is, or what in fact, the Town is planning to execute. It is the shared opinion of many of the neighbors and as I understand it, even a couple of the neighbors in wheelchairs that this plan, as structured, is undesirable for the neighborhood. Many of the residents had thought a handicap parking place was going to be designated somewhere on the curb parking, parallel to the street. It was not until recently, we have come to realize what the Town's plan is and can actually see the site plan. We are not opposed to handicap parking, but what we are objecting to the new design.

Please consider other options for this area like pavers, gravel, or tough ground cover like Creeping Thyme.

There are some troubling down-sides to artificial turf:

Gets hot in the heat

While you can play on artificial grass during the time of year, during the hot summer when it is exposed to the sun for the majority of the day, it can become quite hot and uncomfortable. It is not uncommon for the temperature of artificial grass surfaces to be 37° warmer than the air temperature around it. The grass emits a strong rubber smell.

Runoff

Runoff is a major concern with artificial grass as any chemicals that are in the product can easily be taken to water sources. Hard rainstorms are a problem as they can cause a lot of water runoff that may potentially be toxic.

Toxic materials and harmful chemicals?

Artificial grass contains a known allergen latex and a host of phthalates, or plasticizers. The plasticizers break down and release potentially harmful substances that affect the kidneys, lungs, reproductive organs and liver if breathed in or accidentally ingested. The grass leaches toxic metals, such as arsenic, cadmium, chromium, lead and zinc. It is also associated with carcinogens like polycyclic aromatic hydrocarbons, or PAHs.

Some medical experts believe that there is enough lead in artificial grass to pose health hazards, especially to children. They state that the amount of lead in the product is enough to cause decreased development, mental retardation, and even death with prolonged exposure. Asthmatics will most likely struggle to breathe after playing on artificial grass for an extended period of time due to its effects on asthma.

Become a breeding ground for certain bacteria

Unlike natural grass which can not only withstand some bacteria but also allow cells and other materials to seep into the ground, artificial grass can become a breeding ground for certain bacteria. Studies have shown that staphylococci can stay on the type of plastic used in the production of artificial grass for more than 90 days. Additionally, any blood, skin, or other biological materials that are left on artificial grass will not easily wash away into the ground unless they are specifically removed by a person.

Environmental Impacts

Artificial grass does not cool the environment as natural turf does. It does not filter air or water pollutants like natural turf either. Artificial grass tends to produce runoff after periods of heavy rainfall. The runoff bypasses sewage treatment systems and discharges contaminated water into nearby surface waters. Sometimes it is necessary to install an irrigation system under the lawn to ensure better drainage of storm water.

Artificial grass does not have the biological means to fend off fungus or bacteria. Athletic fields receive disinfectant treatments to prevent the potential spread of staph infections. Residential lawns also require cleaning as part of regular sanitation. Homeowners hose off wind-blown leaves, dust and debris and must scrub pet waste with water and detergent. The plastic blades in high traffic areas need periodic mechanical defibrillation, or "fluffing," to restore their appearance.

Artificial turf is far from an eco-friendly alternative to natural grass. "It blocks access to the soil beneath for burrowing insects, such as solitary bees, and the ground above for soil dwellers such as worms, which will be starved of food beneath it," says Paul Hetherington, fundraising director for the charity Buglife. "It provides food for absolutely no living creatures.

The common practice of replacing soil with sand to provide a more stable bed for the fake grass also releases even more CO₂ stored in the earth, according to David Elliott, chief executive of tree-planting charity Trees for Cities.

There is also the matter of microplastics: the tiny particles of plastic that have made their way throughout the globe, and are present in our food, water and even the air.

Mr. Hays,

Good morning. Thank you for your interest in this Town project. Consistent with the prior public meetings and the PRAC meeting, the responses to your questions are in blue text as follows:

- 1. The rationale for ADA parking at Three Weirs Park.
 - The Town is obligated to comply with the American with Disabilities Act (ADA), a comprehensive civil rights law to assure equality of opportunity, full participation, and independent living, for people with disabilities.
 - The Town adopted an ADA transition plan in 2015 to comply with the American with Disabilities Act (ADA). As part of this ADA Transition Plan, the Town is providing accessible improvements at public facilities, public parks, and public parking throughout town.
 - Three Weirs and Forrester Park were specifically identified as lacking adequate accessible parking and access.
 - Three Weirs Park currently has public parking at public facility with no accessible parking stall and a ramp to a public pedestrian trail that is not compliant with ADA standards.
- 2. Whether alternatives exist that might better meet both legal requirements and the interests and needs of the community.
 - To date, there has not been an option that meet the legal ADA requirements and satisfy the aesthetic concerns from the handful of residents that have come forward to provide feedback. The options are as follows:

• Install an ADA parking stall and reconstruct the ramp to the pedestrian trail to meet ADA standards.

• Remove public street parking from this public facility and reconstruct the ramp to the pedestrian trail to meet ADA standards. This will require additional

review to what will be required for ADA if there are no accessible paths within the neighborhood.

• Do nothing. The Town has the design, the funds, and the ability to provide accessibility improvements at a public facility. If the Town chooses not to provide these improvements a greater liability issue is created. This could require the ADA transition plan to be revisited and revised and potential adjustments to entrance the Hopper Creek Pedestrian Trail.

- 3. The process the town uses to invite and evaluate design suggestions from the public.
 - Typically, when projects are smaller and do not encroach in any private property the community meetings are geared towards informational updates and not in-depth design collaborations.
 - However, given the sensitive nature of this project in this location, the Town has hosted various community meetings to collaborate with the groups of community members who have been willing to participate.
 - We have incorporated the results of those collaborative meetings and created multiple design options based off that feedback.

I'm hoping you would be willing to help me by responding to the following questions:

- If ADA parking at Three Weirs Park is required by law, is it because parking already exists there? Or is it because it's a public park (regardless of whether contiguous parking exists)? In other words, if a public park exists, but no parking is available at that park, is there a requirement to install ADA parking?
 - The Town is required to provide an accessible parking stall where public parking is provided.
 - The designation of this area, regardless of it being a "park", "open space" or "public facility", is not the governing factor in the requirement for the ADA parking stall.
 - However, Three Weirs Park and this neighborhood are in a unique situation where accessible paths in the neighborhood are intentionally omitted. The omission of sidewalks was included in the ADA Transition plan based on community feedback.
 - That said, the Hopper Creek Pedestrian Trial has a direct connection to this neighborhood via an intentional pedestrian bridge and ramp that leads into the neighborhood.
 - The ramp from the neighborhood to the trail is not compliant nor is the curb cut into the street.
 - Regardless of the parking situation, the access to the pathway to the bridge needs to be ADA compliant.
- 2. If the raised shoulder that currently exists along the front of Three Weirs Park were to be reconfigured in its entirety into a conventional sidewalk with curb (eliminating parking in front of the park) would that obviate the legal requirement to install ADA parking at the park?
- The removal of parking could remove the requirement for the ADA accessible parking stall.
- The connection to the pedestrian trail to the neighborhood would still need to be addressed to meet ADA standards.
 - 3. In lieu of the current design, which lays the wheelchair-accessible path to the Hopper Creek Path right through the park, could the existing raised shoulder be replaced by a conventional sidewalk that serves as a wheelchair-accessible path to the Hopper Creek Path?
 - The Town had multiple designs created based on community feedback and adjustments. One design has a path that cuts through the park and the other design has a path keeps to the corner of the park closest to the existing path and utilizes the area of the existing path.
 - Converting the existing raised shoulder to sidewalk is the same as removing public parking from this area. This is an option that will require review from the Town attorney

4. Is the primary motivation for ADA parking at Three Weirs Park access to:

a. Hopper Creek Path? If so, why wouldn't that be more effectively and less obtrusively accomplished by ADA parking at one or both ends of the path, i.e., at Finnell Rd and/or Yount St?

- The motivation to provide ADA parking at this location is as stated above. Three Weirs Park currently has public parking at public facility with no accessible parking stall and a ramp to a public pedestrian trail that is not compliant with ADA standards.
- ADA Parking at other location as proposed at Finnell and Yount St fail to provide ADA access to and from the Washington Park neighborhood and contiguous Stags View neighborhood.

b. Three Weirs Park itself? If so, how would you address concerns that, given the small size of the park, the proposed ADA parking design is certain to have an inordinate impact on the aesthetic, ambience, and functionality of the park and neighborhood?

- The design consultant was given instructions to provide the least impactful design that would provide ADA compliance.
- The preferred design presented to the community that keeps the parking stall and path the far west of the park is the least impactful.
- We are utilizing as much of the existing paved shoulder and existing paved trail area as possible to minimize how much green area is removed.
- The <u>NEW</u> hard surfaces (concrete or asphalt) are approximately 500 square feet. The total park green area before this project is approximately 6,500 SF. The total parking stall would only impact approximately 8% of the park.
- There are no design options that would have no impact to this location. The land will still be accessible to the residents and their pets, the bench and trash cans will remain, and access to the pedestrian trail will remain.

5. Is there a process in place to actively solicit and evaluate design suggestions from community members? (In addition to the existing process to solicit community input on professionally prepared designs.)

- The process of hosting multiple public meetings, collaborating on the design of the project and revising the design based on that collaboration already exists and is taking place as evidenced by the attendance at the multiple public meetings.
- The size and scope of this project does not open itself to greater additional methods of soliciting design suggestions from the community.
 - For example, this project does not encroach on a private property, it does not remove a park from the neighborhood, and it does not add a change in traffic patterns that could cause harm or confusion to drivers.
 - Larger projects with a larger impact on the Town residents or drivers, could potentially include more options. The Town submitted all design suggestions received from the community to the design engineer. They reviewed the suggestions and used the elements that would still allow for ADA compliance in their revised designs.
- If the Town moves forward with this project, we will have to construct a design that was created by the licensed engineer of record. This is mandatory to verify that the design alternative is ADA compliant.

Additionally, the Town's goal is to follow the ADA Transition Plan and provide ADA compliant features as required by law. By doing nothing at this site, the Town is increasing its risk to lawsuits and fines because doing nothing has the effect of excluding or discriminating against persons with disabilities.

This accessible parking stall is the least impactful of these options. 2010 ADA standards require "[a]t least one accessible route shall be provided within the site from accessible parking spaces and accessible passenger loading zones; public streets and sidewalks; and public transportation stops to the accessible building or **facility** entrance they serve." If we choose to not provide an accessible

parking stall and no accessible connection, not only could the public parking be removed but the access to the pedestrian bridge and trail may face removal as well. The Town cannot remove a project to provide ADA facilities based on public comments, courts have held this reason is insufficient to avoid ADA compliance.

The public's opportunity to participate still exists as the process moves forward to Town Council. The Town will present the updated designs and the various options explained above to the public and the Town Council. I will also include a legal insight, with the help of our Town Attorney, on various liability and legal repercussions we could face on these various project alternatives.

Dear Rosalba:

First, I'd like to express my appreciation to you for generously providing me with information about these ADA accessibility projects and answering my many questions. I now have a much better understanding of this situation.

Although I'm sure there are many aspects that I still *don't* understand, I'd like to offer for consideration a design overview that I believe may address the needs involved, including:

- Access
- Inclusion
- Legal compliance
- Liability protection
- Aesthetics

My intention is to imagine a constellation of integrated strategies that meets all needs of the whole system, that is, the community made up of residents, visitors, businesses, and governments, as well as the physical environment in which all are embedded. I realize this is a balancing act and it's difficult to fully meet every interest and need. (My sympathies to those whose jobs demand that they walk this tightrope every day.)

Project goals:

- Create a welcoming and inclusive atmosphere in Yountville.
- Comply with ADA regulations.
- Protect town from liability.
- Improve access to:
 - Hopper Creek Path
 - Three Weirs Park
 - o Forrester Park
 - $\circ~\mbox{Pedestrian}$ path that currently exists in Washington Park
 - Washington Park neighborhood
- Enhance the aesthetic and ambiance of Three Weirs Park, Forrester Park, and the Washington Park neighborhood.

Project tasks designed to meet the goals mentioned above:

- Construct ADA compliant parking on Finnell Road where Hopper Creek Path intersects.
- Construct ADA compliant parking on Yount Street where Hopper Creek Path intersects.
- Construct ADA compliant parking on Redwood Drive at Forrester Park.
- Eliminate all parking at Three Weirs Park.
- Reconfigure the existing raised shoulder at Three Weirs Park into an ADA compliant pathway from

Three Weirs Park to the bridge over Hopper Creek.

Why I think this approach could work:

- Establishes multiple ADA compliant parking areas, providing access to all areas of concern.
- ADA parking on Finnell and Yount would be more visible and more easily located than parking at Three Weirs Park. This is especially important for visitors who may be unfamiliar with Yountville.
- ADA parking on Finnell and Yount would have less adverse impact than parking at Three Weirs Park.
- Three Weirs Park would be fully accessible from either end of Hopper Creek Path via the bridge
- over Hopper Creek.Complies with ADA regulations.
- Does a reasonable job of protecting the town from liability.
- Maintains to a reasonable degree the aesthetic and ambiance of Three Weirs Park and the Washington Park neighborhood.

I welcome any comments, perspectives, and thoughts about my specific design suggestions or about this situation in general.
