DISCUSSION/BACKGROUND

Paving Project

At the July 19, 2022, Town Council meeting, Council awarded the MT-3023 Measure T Street Rehabilitation at Various Locations Project to J.V. Lucas Paving of Martinez, CA at a bid price of \$318,967.30. This project consists of the rehabilitation of Yount Mill Road from Yount Street to the Town Limits, Mesa Ct. from Yountville Crossroad to end, Humboldt St. from Washington St. to Yount St., and Harvest Ct. from Heritage Way to end, Rehabilitation to consist of grinding the existing asphalt and overlaying the street surface with new hot-mix asphalt. Also included in this project are repairs to smaller sections of roadway on Finnell Rd from Yount St. to the east Town limits in preparation for the following fiscal year's Measure T microsurfacing project.

The project required 1 additional change order totaling \$13,716.00 to complete the project. This change order provided improvements to the public parking bays on Mesa Ct. The total price to complete the project:

Awarded Bid Price \$318,967.30
Change Order Additions \$13,716.00
Total Project Cost \$332,683.30

Pavement Condition Index

A Pavement Condition Index (PCI) score is developed for each street segment in the Town with the score measured between 0-100 (Poor to Excellent). The PCI indicates the quality of the street and determines the best type of pavement treatment to increase the score. The average PCI for the Town of Yountville prior to this project stood at 77. A 77 PCI is a high number and indicates high-quality streets within the Town which is also the highest PCI score within Napa Valley. With the repairs provided from this project on Yount Mill Rd., Mesa Ct., Harvest Ct., Humboldt Street, and Finnell Rd., the Town's average PCI is estimated to be 80, which has been a goal of the Town Council for quite some time.

All of the work has been completed to the satisfaction of the Public Works Department. By this resolution, the Town Council authorizes the Director of Public Works to execute the Notice of Completion and directs the Town Clerk to file said Notice of Completion with the Napa County Clerk Recorder.
