Capital Improvement Project WW-0021 Sanitary Sewer Sliplining Project Update

DISCUSSION/BACKGROUND

At the June 15, 2021 Town Council meeting, Council approved the 2021-22 Capital Improvement Plan with WW-0021, the Annual Sanitary Sewer Sliplining Project. This is the Town's annual commitment to reducing the inflow and infiltration into the sanitary sewer collection system which in turn reduces the volume of water that needs to be treated at the wastewater treatment plant.

The project was successfully bid and awarded on March 2, 2021 to Miksis Services Inc. of Healdsburg for \$155,000. The scope of work for the FY 20-21 project included: Clean and video inspect all sewer lines subject to sliplining this year; slip-lining 145 linear feet of sewer line C2 in Mesa Court; slip-lining 278 linear feet of sewer line A2 in Beard Ditch east of Washington Park; constructing a new maintenance hole and slip-lining 765 linear feet of sewer line A1 in Beard Ditch east of Rancho de Napa; and reinstating all lateral connections to the newly slip-lined pipes.

The method of sliplining was a fold and form technique where lengths of folded PVC Pipe are pulled through the inside of the existing pipe then heated and air compressed into shape. The work is now complete after delays in receiving adequate plastic pipe material.

These types of capital improvement project are a significant improvement to our infrastructure but largely go unnoticed. As such, staff will be proving a brief presentation about this project to Council to highlight such improvements to our overall utility operation.
