

Introduce and Waive First Reading of Ordinance Number 21-502 Amending the Yountville Municipal Code to Amend the Zoning Map to Designate the Properties Located at 6468 Washington Street (APN 910-011-507) and 6424 Washington Street (APN 910-011-474) with the Senior Mobile Home Park Overlay (-S).

DISCUSSION/BACKGROUND

On August 3, 2021, the Town Council unanimously voted to introduce and waive the first reading of Ordinance 21-501, which substantially amends Title 17 (Zoning), repeals Title 18 (Design Standards), and incorporates the design standards into Title 17, with associated revisions to Title 6 (Animals), Title 12 (Streets, Sidewalks, Public Places and Parks), Title 15 (Buildings and Construction), and Title 16 (Subdivisions). The second reading and adoption of Ordinance 21-501 is before the Town Council this afternoon.

Ordinance 21-501 includes a new Senior Mobile Home Park Overlay. This new overlay district was created from current Section 17.44.070 of the Yountville Municipal Code and is applied to mobile home parks with a senior-only restriction. The map amendment before the Town Council includes the new Senior Mobile Home Park Overlay and amends the Yountville Zoning Map to designate the two properties that are subject to the overlay. That map is attached to this staff report.

ENVIRONMENTAL REVIEW

Addendum to the General Plan EIR has been prepared. The proposed Zoning Ordinance Update project would bring components of the Yountville Municipal Code and Zoning Districts Map into compliance with the General Plan as analyzed in the General Plan EIR and would not result in any new impacts or increase the severity of previously identified significant impacts analyzed in the certified EIR. No new mitigations measures would be required. The Zoning Ordinance Update project would not result in a substantial change to the project analyzed in the EIR, so additional environmental review is not necessary and no new information is known that triggers the need for additional environmental review.
