Adopt Resolution Number 22-4110 Authorizing a budget adjustment from Fund 26 SB 6022 Balance to the new MT 3023 Measure T project in the amount of \$27,275.50.

## **DISCUSSION/BACKGROUND**

At the December 7, 2021, Town Council meeting, Town Council adopted the 2022-2027 Measure T 5-Year plan. This plan includes roadway rehabilitation on various streets in Town of which; plans, specifications and costs estimates are required to publicly bid for the construction work. The design, preparation of plans, specifications and estimates are funded by Gas Tax revenue while the actual construction work is funded by Measure T.

This year's Measure T project, Washington Street Rehabilitation from Yount Street to the southern Town limits began construction in October 2021 which was not ideal due to the weather conditions associated with the late fall and winter months. Due to construction on Washington Street starting in October, the Town encountered various weather scheduling challenges and cost increases associated with weather delays. Since the Measure T funds for the 22/23 fiscal year are available after July 1, 2022, Public Works would like to begin construction on the 22/23 Measure T projects as soon as the funds are available after July 1, 2022, to avoid weather-related issues. This requires the design, plans, specifications and estimates to be completed in May.

To meet this goal, Public Works has contracted Pavement Engineering Inc. for design services to be performed now in advance of the 22/23 Measure T work scheduled to start after July 1<sup>st</sup>. The PEI contract includes measuring field quantities, preparing contract documents (plans and technical specifications), estimates and providing bid support services. The total contract price is \$44,455.00.

The current Gas Tax fund account GT 3022 used for designing plans and specifications has a balance of \$13,109.50 which is insufficient to cover the full contract price. To make up the difference staff is proposing to apply the remaining Measure T 3022 budget of \$4,070 and also requesting a budget adjustment of \$27,275.50 from available SB 6022 which has a current balance of \$50,000. The SB-6022 fund consists of SB-1 revenues used for roadway maintenance and rehabilitation work and a remaining balance of \$22,724.50 if this budget adjustment is approved.
